Description

Goats were immunized with antigen grade **human IgM**. Antibodies have been isolated using ammonium sulfate, ion-exchange, and affinity chromatography to remove non-specific antibodies. Specificity of antibody has been tested using IEP, immunodiffusion, and ELISA. The product reacts with human IgM with no significant reactivity with human IgG, or other serum proteins. The antibody may recognize other species IgM. Purified anti-human IgM antibody is supplied as unlabeled or conjugated to Biotin, FITC, AP or HRP.

Suggested conjugate dilutions are 1:200-1:2000 for immunofluorescence.

Form and Storage

Cat# 10219, Anti-human IgM, unlabeled

The antibody is supplied in PBS, pH 7.4, and 0.05% azide in either **lyophilized** (0.5 mg) or **liquid** form (0.5 mg/0.5 ml). Reconstitute powder in PBS in 0.5 ml to prepare 1 mg/ml solution. Store at -20°C in suitable aliquots. Stability is ~6-12 months. Do not freeze and thaw.

Purified anti-human IgM antibody was coupled to Biotin using Biotinamidocaproate N-Hydroxysuccinimide Ester (BAC) at F/P ratio ~10-20:1. The antibody is supplied in PBS, pH 7.4, 0.2% BSA and 0.05% azide in either **lyophilized** (0.5 mg) or **liquid** form (0.5 mg/0.5 ml). Reconstitute powder in PBS in 0.5 ml to prepare 1 mg/ml solution. Store at -20°C in suitable aliquots. Stability is ~6-12 months. Do not freeze and thaw.

Suggested conjugate dilutions are 1:5,000-1:30,000 ELISA, 1:2K-1:10K for western.

Cat# 10220, Anti-human IgM-HRP-conjugate

Purified antibody was coupled to HRP (RZ>3.0) using periodate method. The molar enzyme to protein (E/P) ratio = 4.0. The antibody is supplied in stabilizing buffer, 0.1% proclin-300 as preservative in , either **lyophilized** (0.5 ml) or **liquid** form (0.5 mg/0.5 ml). Reconstitute powder in PBS in 0.5 ml. Store at 4°C in suitable aliquots. Stability is ~6-12 months. Do not freeze and thaw.

Recommended Working Dilution for ELISA

Working dilution for the specific application should be determined by the investigator to obtain the best conditions. Working solution should be prepared immediately before use and diluted solution should be discarded.

Suggested conjugate dilutions are 1:1,000-1:10,000 ELISA, 1:1K-1:5K for western, and 1:200-1:1000 (IHC).

Cat# 10250, Anti-human IgM,-AP-conjugate

The conjugate is provided at ~0.5-1 mg/ml as liquid in a stabilizing buffer (50 mM HEPES pH 7.1, 0.1 M NaCl, 1 mM MgCl₂, 0.1 mM ZnCl₂, pH 7.5, containing 0.2% bovine serum albumin, 0.05% sodium azide). The product should be **stored at 4°C** and is stable for a minimum of 1 year. Do not store diluted solutions.

Purified anti-human IgM antibody was coupled to FITC at F/P ratio ~3:7. The antibody is supplied in PBS, pH 7.4, 0.2% BSA
