**Normal/Pre-immune Control Monkey (Cynomolgous) Serum (IgG's-Depleted)**

**Description**

A Donor population of adult Monkey (Cynomolgous) (mixed sex) was used to collect serum (#NMCS-1). IgG's were depleted over repeated adsorption over ADI's Protein A/G column. IgG-Depleted serum was tested using monkey IgG ELISA kit # 7050 with a sensitivity of ~ 5 ng/ml. Depleted sera showed non-detectable IgG levels. It is supplied as non-diluted serum with 0.1% azide as preservative. This preparation is not sterile.

**Form and Storage**

Normal Monkey (Cyno) serum is provided as liquid and 0.1% sodium azide as preservative or in lyophilized form. The product should be **stored at 4°C** for short term and -20°C for long term storage. It is stable for a minimum of 1 year. Unless species otherwise, this preparation is not sterile.

The **lyophilized products** should be dissolved in PBS, pH 7.4 in original volume of serum (1, 10, 100, 500mls) to bring it to original volume. Mix gently for 15-20 min at room temperature. Centrifuge the solution briefly (10,000 g, 15 min) to remove any floating lipids or particulate matter. It should be aliquoted and stored frozen for long term use.

**Suggested Uses**

This preparation of normal Monkey (Cyno) serum is suitable for blocking in a given immunoassay or to serve as non-immune serum control for various primary antiserum. It may not be an ideal negative control for all primary antibodies as it is preferred to use the serum from the same Monkey (Cyno) before any immunization. Control Monkey (Cyno) serum should be diluted the same way as the primary antiserum. It may also be used to pre-treat the antibody beads during the immunoprecipitation to suppress non-specific adsorption of primary antibodies. Another use could be to use it as -ve control in ELISA for various primary antibodies, for which no pre-immune is available.
